B. Mauthe, President of the Pembina Trails Teachers' Association made a presentation to the Board with respect to the 2018-19 Draft Budget.

(DELEGATIONS) (Issue #20180206001) The Delegation circulated a handout. B. Mauthe raised questions regarding pupil-teacher ratios and the average teacher's salary both derived from the Board's 2018-19 Draft Budget disclosed on February 8, 2018. The Secretary-Treasurer explained the causes for the change in the average teacher's salary which causes include:

- 1. The teachers' salary schedule in 2017-18 was a split grid which meant that there were increases in the salary rates effective for the period September through December 2017 and a further increase in the salary rates effective for the period January 1, 2018 through August 31, 2018. For the period September 2018 through August 31, 2019, the salary rates in effect would be the salary rates prevailing on August 31, 2018, for the full year thereby causing an increase in the average teacher's salary.
- 2. The change in the category of staff being budgeted for 2018-19, namely, more school administrators would contribute to a higher teacher's average salary;
- Step increments, increases in teacher qualifications and changes in the mix of staff in classes and steps due to retirements, terminations and new hires would also lead to an increased average teacher's salary.

The Assistant Superintendent, Human Resources and Policy, explained why the growth in the number of students is not matched by a commensurate increase in the number of teachers which explanation included the impact of the discontinuation of 20K3.
