She reviewed the history between the Ryerson School Age Centre and Pembina Trails School Division.. She said that they had donated \$8,000 toward Ryerson play structure and had not been publicly recognized for that donation. They claimed that they did not get an explanation with respect to their rent obligation and now have a large balance payable. The Chair of the Board stated that this matter will be considered by the Board in September and a response will be forthcoming at that time.
