7. EDUCATIONAL PRESENTATIONS

7.1 Indigenous Education

K. Lamoureux, Indigenous Scholar in Residence for the Pembina Trails School Division made a presentation to the Board. He reviewed his report. He said that reconciliation for him is the work of the Truth and Reconciliation Commission. He said the call to action, as educators, is a social movement to leave Canada a better place. He said that reconciliation is not something done for indigenous students out of pity. Achieving reconciliation does not mean doing less in some other area, reconciliation should help everyone. He said that reconciliation has to involve education especially in the public schools. He said that we should be proud of Canada but at the same time recognize that we can be an even better place. He said that Pembina Trails is rich in efficiency and structure and has potential to leap to the head of the pack in the area of reconciliation.

He said that some areas of concern in Pembina Trails are:

- Some attitudinal positions;
- Teachers or Administrators feeling that they need to get permission to step outside of the standard;
- School Administrators should be given permission to explore possibilities in this area and were that to happen, we should see positive steps quickly, especially at the Senior Years level. We need to step outside of our comfort zone.

K. Lamoureux noted that his association with Pembina Trails has been very positive. He invited Trustees to ask questions. He said that we need to have a broader set of relationships at the Senior Years level and should not only have good relationships with the university level but with colleges and other institutions as well.

He said that many indigenous students have excellent experiences at the elementary and middle years levels but the fast pace of the high schools is a jarring experience for them. He said that going about business as usual makes it difficult for teachers at the high school level to allow them to show their caring nature for the students.

He said that reconciliation is different than multiculturalism as other cultures never functioned nor were subject to legislation like the *Indian Act*. He said that indigenous people have been treated as "others" and we would like to dissipate that "otherness".

D. Zuk asked if Pembina Trails should be more assertive than we are now with respect to reconciliation. K. Lamoureux said that he sees Reconciliation having no disconnect or conflict with our Expectations for Student Learning. He said that Pembina trails is very strong in terms of its hierarchy and that the teachers need to have permission to do these things within checks and balances. He does not think that reconciliation should be pushy but more invitational.

He said he had been asked to work on a commission studying the educational success for children in foster care which was found to be abysmal. In his view, Pembina Trails should try to help in this area by focusing support and help for children in care.

The Superintendent suggested that the Education Committee could be assigned to study and recommend regarding the report.

T. Johnson said he would like to review the report more extensively in a Committee Meeting of the Whole.

The Assistant Superintendent, Program, said that the Indigenous Student Support Teachers have not yet seen the report. He said he meets with them semi-monthly. He said that we can compare the components of the Budget Study to see how it conforms to the Report.

13. STANDING AND SPECIAL/ADVISORY COMMITTEE REPORTS

13.1 Buildings, Property and Transportation Committee

13.1.1 Transportation Budget Study

T. Johnson said that earlier this year there had been a presentation from a parent regarding seat sales. He said that the Board approved the addition of Adult Crossing Guards on McGillivray and Dovercourt but there was also a desire to study expansion of transportation service. T. Johnson said that the study looked at a portion of grades 7-9 enrolment. The Assistant Superintendent, Divisional Support Services, said that there are only 850 grade 7-9 students who would be impacted out of a total grade 7-9 population of 3,409. She explained the definition of "Hazardous Roadways".

The Assistant Superintendent, Divisional Support Services, offered additional information related to this report. A narrative summary has been prepared and is attached to these minutes.

WHEREAS the Committee reviewed the number of additional routes required to provide transportation service to grades 7, 8 and 9 using the existing criteria of distance to the designated school and crossing of hazardous roadways; and

WHEREAS the Committee reviewed the additional cost (\$1,157,000) to add the additional bus routes, implications of re-defining hazardous roadways in Policy, Adult Crossing Guards, the resulting cost of seat sale fees and the comparative seat sale fees among other Metro Winnipeg school divisions;

THEREFORE BE IT RESOLVED THAT the Transportation Budget not be increased for 2020/21 to provide expansion of transportation services to grades 7, 8 and 9.
