#### 19. QUESTIONS FROM MEMBERS OF THE PUBLIC IN ATTENDANCE

Members of the public asked the Board for clarification regarding the decision making process which led to the adjustment of school start times in response to transportation issues. Some of the concerns raised by parents were student safety, additional childcare costs and daycare capacity, health implications for students and the impact on working parents managing conflicting school and work schedules.

The Board and Senior Administration responded to parent questions reiterating that the challenges faced by the division's transportation department are impacting the transportation industry as a whole. They confirmed that 33 of the 53 buses are operating at 85% capacity, and the remaining buses are in excess of 90% capacity. The Superintendent acknowledged the impact to families and went on to explain that with competing interests in bus driver recruitment, and the continuing growth in Waverley West, adjustments to school start times is seen as the only feasible solution at this time.
