# 7. DELEGATIONS

# 7.1 Parent Delegation - S. Zhou and T. Chen

S. Zhou and T. Chen made a presentation to the Board, expressing their concern about the safety of the location of their children's bus stop, located at Sablewood Road and Bridge Lake Drive. They expressed concern at the proximity to the roundabout on Eagleview Road and the fact that in the winter it will be difficult for cars to stop. It is their view that this puts their children in danger. The delegation(s) have requested that the current bus stop location be moved or that their children be routed onto a different bus that is closer to their home.

# 7.2 Parent Delegation - M. Sarhan

The delegation raised concerns about the discontinuation of the bus service that was previously provided to Fairfield Park students attending Chancellor School. He acknowledged that although he is 1.5 km from the school, he and his wife do not have time to take their children to school due to other commitments and their children are unable to walk that far, especially in the winter, through the snow and in cold weather. The delegation requested that his children be provided bussing.

#### 11. BUSINESS FROM PREVIOUS COMMITTEE MEETING OF THE WHOLE

# 11.1 Fort Richmond 9-12 Students Moving to Pembina Trails Collegiate

The Assistant Superintendent, Personnel and Education Services, provided projected enrolment numbers for Pembina Trails Collegiate and Fort Richmond Collegiate for 2023-24, based on September 30, 2021 enrolment data at the September 8, 2022, Committee Meeting of the Whole. It was noted that the Administration's recommendation is for Pembina Trails Collegiate (PTC) to open with students residing in Waverley West in grades 9-11. Grade 12s would stay at FRC and would not be given the option of moving to PTC. 2024/25 would operate with grades 9-12.

In response to a question from Trustee J. Fisher, Administration confirmed that grade 12 students living in Waverley West would attend their current catchment school in 2023. Trustee C. Nachtigall asked the Assistant Superintendent, Personnel and Education Services, to elaborate on the process of making this decision. Hestated that after speaking with stakeholders it was clear of the importance of students to be provided with the opportunity to graduate with their peers. It was also determined that continuity in programming for grade 12 students was of the utmost importance and that, out of necessity, the programming options at PTC will need to be built out over time, meaning that students will not have access to the myriad of options available to them at their current high schools.

AND WHEREAS Pembina Trails Collegiate will serve the community of Waverley West for English programming grades 9-12 as outlined in a motion passed by the Board of Trustees on November 25, 2021;

AND WHEREAS Administration has presented information to the Board of Trustees outlining transition strategies that will best support maintaining both established student community connections and the continuity of programming during the grade 12 year; therefore

BE IT RESOLVED that the Board of Trustees approves that Pembina Trails Collegiate will open to all English program catchment students and schools-of-choice students in Grades 9-11 in the 2023-2024 school year and subsequently for students in Grades 9-12 English programming catchment students and schools-of-choice students beginning in the 2024-2025 school year.
